
## Corporate Governance 企業管治



Designated by the Government of HKSAR to administer the .hk domain, a public resource of the Hong Kong community, HKIRC endeavours to implement good corporate governance within the organisation to ensure that the administration is conducted in an open, transparent and fair manner.

### Memorandum of Understanding and Designation Agreement with the Government of HKSAR

The Company signed a Memorandum of Understanding (MoU) and a Designation Agreement (DA) with the government of HKSAR on 17 March 2010.

#### **Consultative and Advisory Panel (CAP)**

The CAP met three times on 6 June 2017, 30 Oct 2017 and 5 December 2017. Advisors from different sectors have been invited to sit on the CAP and advise HKIRC on policy issues and matters which help HKIRC serve the local Internet community better.

Last year, HKIRC appointed an independent consulting firm to conduct a review of our current Registry/Registrar ("RR") model and the corporate governance. While the corporate governance was still being conducted, the results of the RR model review had been presented to the Board and CAP meeting in 2017.

#### 與特區政府制定簽訂諒解備忘錄及授權 協議書

HKIRC已經與香港特別行政區政府於2010年3月17日簽署諒解備忘錄(MoU)及指定安排協議(DA)。

#### 諮詢委員會(CAP)

CAP 於2017年6月6日、10月30日 及12月5日分別召開三次會議:獲邀的成員來自不同界別,就HKIRC對互聯網域名管理政策及事務的議題上,及如何為本地社群提供更佳服務表達意見。

去年,HKIRC委託一所獨立的顧問公司就現有的註冊管理機構/註冊商(RR)模式和公司治理進行審查。雖然企業管治仍在進行檢討,但RR報告的結果已於2017年提交給董事局和CAP委員會。
