

Domain Naming Standard 域名命名標準

Under the premise of the Domain Name Registration's policy procedures and guidelines for .hk and .香港 , the following outlines common situations of non-standard domain naming.

在無損域名註冊政策、程序與指引 .hk 及.香港的域名之要求的前提下,以下概述了不可選擇之域名的常見情況:

Violates or may violate any applicable laws or regulations 以任何方式違反或可能違反任何適用的地方、國家或國際法律或法規

- Promote any illegal activities 宣揚任何非法活動
- Promote discrimination based on factors such as race, gender, national origin, disability, or family status 對種族,性別,國籍,殘障或家庭作出歧視
- Advocate for or incite violence 提倡或煽動暴力
- Advocate, promote or incite any party to commit, or assist any unlawful or criminal act under any applicable local, national or international law or regulations 鼓吹、宣揚或煽動任何一方實施或協助任何非法或犯罪行為

Breach legal obligations or infringe any third-party rights 違反對其他人或組織應負有的任何法律責任或侵犯任何第三方的權利

- Copyright 版權
- Any contractual duties 合約義務
- Duty of confidentiality 保密義務

Mislead any individual or organization 誤導或欺騙任何人或組織

- Provide false or misleading information 提供虛假或誤導性資訊違反公共利益(包括但不限於擾亂香港特別行政區政府的運作)或違反被接受的道德原則
- Impersonate any person or organization, or misrepresent the identity or affiliation of Domain Name with any individual or organization 冒充或歪曲任何人或組織或從屬關係

Contradict the public interest, including disrupting government operations or violating moral principles

違反公共利益 (包括但不限於擾亂香港特別行政區政府的運作) 或違反被接受的道德原則

• Disrupting government operations or violating moral principles 擾亂政府運作或違反道德原則

Contain offensive or inappropriate content 含有冒犯性或不恰當的內容

- Be obscene, hateful or inflammatory 淫穢、仇恨或煽動性內容
- Bully, insult, intimidate or humiliate any individual or organization 霸凌、恐嚇或羞辱任何人或組織
- Defame any individual or organization 誹謗任何人或組織
- Be in contempt of court 藐視法庭
- Be threatening, abusive or invade another's privacy, causing unnecessary anxiety 構成威脅、辱罵或侵犯他人私隱, 造成不必要的焦慮
- Be likely to harass any other individual or organization 可能騒 擾任何人或組織
