## **GUIDELINES FOR NOMINATION AND ELECTION OF DIRECTORS**

**Unless as executed by HKIRC, this form will be voided if any term in this form is changed. In case of dispute, the version holds by HKIRC shall prevail and HKIRC reserves the right of final decision.**

**This form may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. Notwithstanding the foregoing, this form (including all counterparts (if any)) must be submitted to HKIRC in one lot by post or by hand (HKIRC Address: Unit 501, Level 5, Core C, Cyberport 3, 100 Cyberport Road, Hong Kong - Attn: C.E.O.). For the avoidance of doubt, if this form (including all counterparts (if any)) is not submitted to HKIRC in one lot, the nomination will NOT be accepted or processed by HKIRC and will be regarded as void.**

The following information contains relevant extracts from the Memorandum and Articles of Association of HKIRC and other information relevant to the election procedure. Please visit **HKIRC M & A** to view the complete Memorandum and Articles of Association.

### ***A. Eligibility for Nomination***

1. Each Candidate shall be a natural person who has attained the age of 18 and is not an undischarged bankrupt.
2. Each Candidate shall be supported by two members from the same class of membership, one member as the “Proposer” and one member as the “Seconder”. Members can only nominate one or more Candidates which is equal to the number of vacancies to the Board of Directors for the relevant class. If a member nominates more candidates than the number of vacancies to the Board of Directors for the relevant class, HKIRC will only process the nominations which are received by HKIRC earlier in time as reasonably determined by HKIRC, up to and equivalent to the number of vacancies to the Board of Directors for the relevant class. Any additional nomination will be regarded as void and not be processed. For the avoidance of doubt, if more than one nomination is submitted to HKIRC in one lot, and such nominations in the lot would mean that a particular member has nominated more candidates than the number of vacancies to the Board of Directors for the relevant class, all the nominations made by that particular member in the said lot will be regarded as void and not be processed.
3. Each Candidate shall provide personal profile and election platform for posting on HKIRC website or/and sending to HKIRC members of relevant class.
4. A Candidate for election to the Board of Directors cannot stand for more than one class of Members at the same election.

### ***B. Eligibility for Proposer and Secunder***

5. Members acting as a Proposer or Secunder to a Candidate shall sign the Director Nomination Form as an indication of their support to the Candidate.
6. Both the Proposer and Secunder must be from the same class of membership as the class for which the Candidate is standing for.
7. Both the Proposer and Secunder must be a valid member. A valid member must have at least one .hk/.香港 domain name in active status and is unexpired as of the Annual General Meeting 2026.
8. HKIRC reserves the right to check the validity of membership of the Proposer and the Secunder whenever needed. Under such circumstances, the Proposer and the Secunder shall comply with the checking requirements of HKIRC. Any non-compliance will result in voiding of the nomination.
9. Member’s Representative must be the person registered in HKIRC’s Members Registration System.

### **C. Election and Voting**

10. The election of Directors of HKIRC shall be conducted at an Annual General Meeting (“AGM”).
11. HKIRC may invite Members to nominate persons for election as Directors of HKIRC at any time before an election is due to take place.
12. If on the close of the nomination period, the number of Candidates standing for election to the Board of Directors for a class is equal to or less than the number of vacancies for such class, the nominated Candidates shall be elected automatically.
13. If the number of Candidates standing for election to the Board of Directors for a class is greater than the number of vacancies for such class, the election to the Board of Directors will be made by voting. HKIRC may invite Members to vote for the Candidates standing for election to the Board of Directors. Each member of a class is entitled to a number of votes which are equal to the number of vacancies to the Board of Directors for the relevant class. No member is allowed to cast more than one vote for each Candidate.
14. The Candidates receiving the greatest number of votes in their favour within their classes will be declared to be elected to the Board of Directors for such class. In the case of an equality of votes, the election shall be decided by drawing lots.
15. If the total number of Non-Appointed Directors (as defined under the Memorandum and Articles of Association of HKIRC) is less than 4, a by-election will be conducted to fill the vacancies within one month.

### **D. Notification**

16. HKIRC will communicate with the Candidate, Proposer and Secunder by email in relation to the nomination. The Candidate, Proposer and Secunder shall have the full responsibility for the accuracy of the email address provided in this nomination form.
17. As internet communications may subject to interruption, transmission delay and error, HKIRC is not liable for any failures, malfunctions in communications facilities not under its control that may affect the accuracy or timeliness of internet communications sent or received by any party.

### **E. Governing Law and Submission to Jurisdiction**

18. Any dispute relating to the nomination and election of Directors of HKIRC shall be resolved in accordance with the laws of Hong Kong and all parties to such dispute irrevocably submit to the exclusive jurisdiction of the Hong Kong courts.
19. If there is any inconsistency between the English version and the Chinese version, ***the English version shall prevail.***
